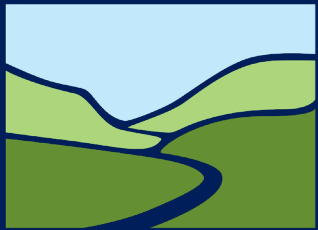

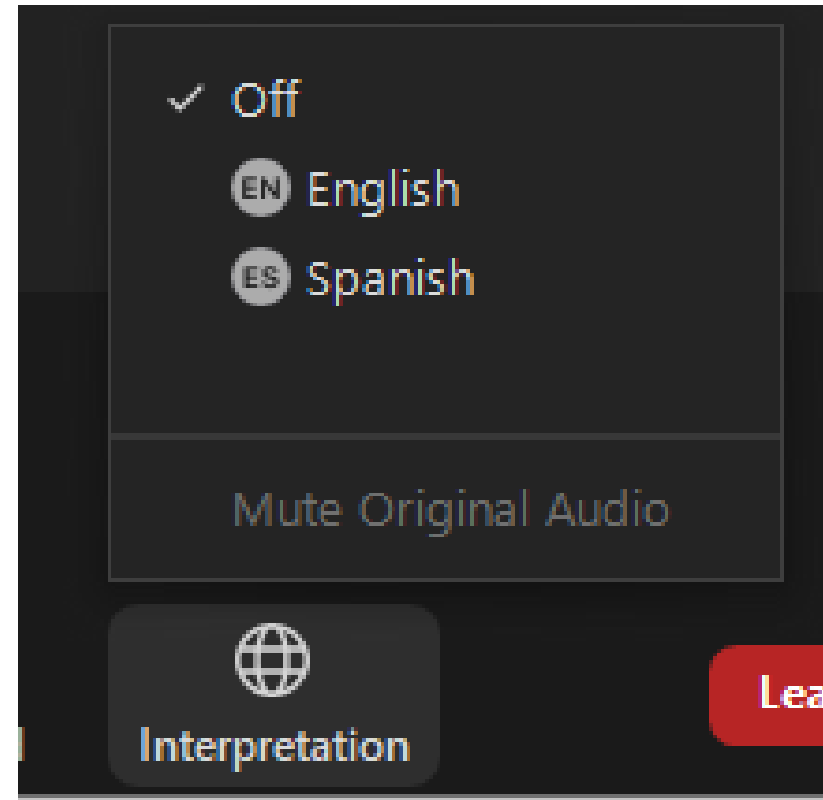

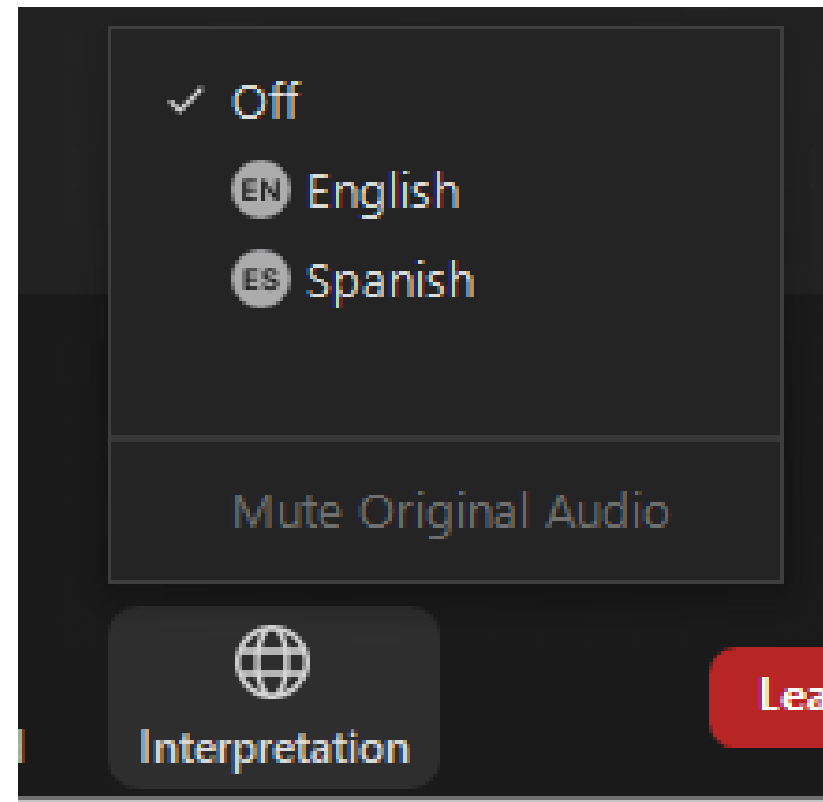

Grant Overview & Goals

The program is made possible by a grant from the Community Foundation of the Texas Hill Country through the Kerr County Flood Relief Fund.

- Grants up to \$50,000.
- All completed applications will be reviewed based on stated and verified business information

Grant Program Qualifications

Applicants must be:

- Must be a small business or non-profit that was operating on or before July 1st, 2025
- Located in Kerr County or Comfort, Texas
- Have suffered negative economic impact and/or loss or damage to business property and/or equipment from the July 4, 2025 floods.
- Previous grant recipients are eligible for consideration for this program.

Grant Awards & Limitations

Funds must be used for business-related expenses, including:

- payroll/healthcare benefits
- contract labor
- working capital
- rent/mortgage or utility payments for business location
- supplier payments
- repair or replace machinery and equipment due to flood related damage or loss

Grant Required Document List

- Valid driver's license of business owner
- Business entity formation document
- Most recent business utility bill
- 2024 filed business tax return and 2025 profit and loss statement.
 - For businesses that began on or after 1/1/25, the January - June 2025 P&L statement + July - December 2025 P&L
- Most recent business bank statement
- Voided check
- Estimates, invoices, or contractor statements for repair work necessitated by the July 4th floods, if business faced physical damage
- Attestation of no duplication of funds (template provided in application)
- 3 photos of physical damage, if business faced physical damage
- 1 photo of your business pre-flood
- Grant resolution (template provided in application)

Grant Required Document List Cont.

- **Non-profits** will be also be asked to submit:
 - List of board of directors
 - 501c3 determination letter

Grant Application Process

- Online application at www.liftfund.com/kerr-county-small-business-recovery-program
- Applications take 30-60 minutes to complete
- Applicants will have the ability to save their progress during the application period
- All proper documentation must be uploaded for an application to be considered complete

Flood Recovery Loan

- **Flexible loan amounts**

- Borrow up to \$500,000 to support recovery and reopening.

- **0% Interest Benefits**

- Loans under \$100,000: 0% interest
- Loans over \$100,000: 0% interest for the first 5 years, then refinanced at market rate for the remaining term.

- **No Added Fees**

- No commitment fee
- No prepayment penalty

- **Flexible Repayment Loan Terms**

- Loans up to \$100,000: 12-120 months
- Loans from \$100,001-\$500,000: Up to 180 months

- **Works Alongside Grant Support**

- Businesses may receive both grant and loan assistance
- Loan participation is optional and does not affect grant eligibility

Flood Recovery Loan

Grant funding alone may not fully cover recovery costs.

The 0% interest buy-down loan can help bridge remaining recovery expenses and support a faster return to normal operations, without the burden of high interest.

This loan option is separate from and does not affect your grant application or eligibility.

We encourage you to explore both options to ensure access to all available recovery capital.
